Old Business

- July Meeting Minutes (NYCU) were approved.
- The Ad Hoc Quorum committee finished all visits and new email addresses have been added to the Google Group to extend invitations to new Intergroup Reps to attend SJIG meetings. An Excel worksheet was prepared to show our expected income and expenses through 12/31/25. The committee is now dissolved. The committee has concluded that an additional donation currently is not plausible.

New Business

- Kathy S-G gave the **Nominations Committee** report. Most positions will continue to be held for next year by the current members except **Registrar** which Michael O will be taking over from Beth M. Open positions are **Vice Chair, Treasurer, 12th Step Within Chair** and **Region 7 Representative**. Please note that anyone willing to take on the position of Treasurer will receive support and guidance from both the prior treasurer and the IG chair to make the transition seamless and easy. Elections will take place in September. You must be present to be elected.
- A motion was made and carried to **move the night of the SJIG meeting from Thursdays to Wednesdays beginning in October**. Due to the eve of the Jewish holiday of Yom Kipper falling on Wednesday, October 1st, the date of the October meeting will be **Wednesday, October 8 2025**. All meetings going forward will take place on the first Wednesday of the month.
- The Ad Hoc Quorum committee, in doing its analysis, noticed that SJIG members are not providing 7th Tradition donations to the IG meetings they attend. Please remember that while we no longer “pass the bag” at our virtual meeting, these donations are still very important and vital to our mission’s success. The chair strongly encourages and suggests we consider supporting our SJIG meeting with the 7th Tradition donation.

- Elaine W. did extensive research into what the expense would be to our IG to place an ad on the inside of NJ Transit buses for a period of 6 weeks on those vehicles traveling from NJ to Philadelphia and back. The cost was close to \$6000. There are some minimal funds available from WSO and Region 7 to offset the costs to our budget, but it still represents a large part of our yearly expected income. A vote was taken, and it was not passed (5 “for” out of a total of 12 possible votes). Included in the discussion were the topics of electronic or static billboards, restaurant menus and other possible print or online venues. Elaine will see what the cost for placing an ad on the exterior of the bus would cost.


