Old Business

- The May Meeting Minutes (NYCU) were approved.
- SJIG meetings are qualified OA meetings that need 7th Tradition support.
- Funding is available from Region 7 to send a delegate to WSBC. This funding must be applied for by October 1, 2026/2027, for WSBC 2027/2028 respectfully. Funding is also available to help in Outreach needs. This funding can be applied for as necessary. It is a good idea to complete this before the new fiscal year starts. Joann M. has volunteered to fill out the necessary forms and bring them to the July meeting.
- A committee was formed to update the 2022 Group Survey. Kathy S-G presented the final 2026 version of the survey making final additions or corrections as comments were offered. She also explained how the survey was to be made available to the membership and received for tabulation and analyzation. A vote was taken and the result was unanimous in its favor. Kathy S-G was also to determine if she could format the survey properly for it to be incorporated into our website and Maryann was to contact Patrick to finalize the placing of the survey on our website. It was estimated that the survey would run through the summer months and be tabulated in September at the earliest.
- Additional descriptions of duties for Officers, Representatives, Delegates and Chairs were due to Elaine W at the June meeting. Most were received. They will serve as a guideline for future volunteers in these service positions. There

already exists a log for the Chair and Treasurer positions. The permanent location of this information has yet to be determined.

- Nominations will be taking place this coming September. Elaine W presented an updated grid from the Nomination Committee showing each position as it currently stood as of 6/10/2026. The following positions are still without nominations: Chair, Vice-Chair, Recording Secretary, YA Committee Chair, PIPO Committee Chair, and Registrar. Nominated to fill the following positions are: Jill T. for Corresponding Secretary, Rita H. for Treasurer, Jane G. and Will K. for Region 7 Representative, Joann M. for 12th Step Within Chair, and Maryann for Website and Technology Chair.

New Business

- Review of the Balance Sheet and Income Statements for the year ending in 2025 was made by Elaine W. and the Financials were unanimously accepted by vote.
- Next Intergroup meeting is on the second Wednesday of the month, July 8, 2026. There will be no summer break taken this year due to the need to monitor the survey.

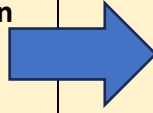
